BANKRUPTCY JUDGE POSITION

BOSTON (June 24, 2008) — Chief Judge Sandra Lynch of the United States Court of Appeals for the First Circuit announced today the formation of a Bankruptcy Merit Selection Panel to screen and review the qualifications of applicants for the vacant bankruptcy judgeship in the District of Massachusetts. The Court of Appeals will seek for this position attorneys with demonstrated excellence in the practice of bankruptcy law and/or commercial or other complex litigation. Given the far-reaching impact that bankruptcies have, the Court wishes to make clear that it encourages applications from candidates who may have either broad or specialized litigation or transactional experience, whether or not such experience is in bankruptcy law.

Under the statute providing for the appointment of bankruptcy judges, the courts of appeals, assisted by the circuit councils, have the duty of filling vacancies on the bankruptcy court in each circuit. 28 U.S.C. § 152. The Merit Selection Panel will recommend to the circuit council individuals whose character, experience, and commitment to equal justice under the law fully qualify them to serve as United States Bankruptcy Judges. Bankruptcy Judges are appointed to fourteen year terms by the Court of Appeals.

Judge Jeffrey R. Howard of the United States Court of Appeals for the First Circuit will chair the Panel. Other members include: Judge F. Dennis Saylor, District Judge from the District of Massachusetts; A. Hugh Scott, Choate, Hall & Stewart; Lena Goldberg, Fidelity Investments; Deborah Birnbach, Goodwin Procter; John Rao, National Consumer Law Center; Gary Wente, Circuit Executive, and Susan Goldberg, Deputy Circuit Executive, will serve as Panel Secretary.

Chief Judge Lynch expressed her appreciation to these attorneys for assisting the court in this important matter.

Applications are available from the Circuit Executive's Office, the Bankruptcy Court Clerk for the District of Massachusetts, the Clerk of the United States Court of Appeals for the First Circuit, or by accessing the Court of Appeals' website at www.ca1.uscourts.gov.

In making the appointment, applicants will be reviewed without discrimination as to race, color, sex, religion, or national origin. Applicants should be admitted to practice in at least one state court and should be members in good standing of every bar to which they belong. Applicants should possess and have a reputation for integrity and good character and be of sound physical and mental health. Applicants must possess and have demonstrated a commitment to equal justice under law. Applicants must also possess and have demonstrated outstanding legal ability and competence as evidenced by substantial legal experience, ability to deal with complex legal problems, aptitude for legal scholarship and writing, and familiarity with courts and court processes. Applicants must also possess demeanor, character, and personality to indicate that they would exhibit judicial temperament if appointed to the position of United States Bankruptcy Judge. The term of office is 14 years and the current salary is \$155,756.

Pursuant to Section 120 of the Bankruptcy Amendments and Federal Judgeship Act of 1984, the Judicial Council of the First Circuit will make recommendations to the United States Court of Appeals which will make the appointment. Applications are to be received by Friday, August 29, 2008.
