ORDER

Petitioner, a pro se litigant, has filed a petition for review of two orders dismissing misconduct complaints that petitioner filed under 28 U.S.C. § 351(a). Petitioner seeks review of Chief Judge Barron's order dismissing petitioner's complaint against a district judge in the First Circuit (Complaint No. 01-22-90001) and Judge Montecalvo's order dismissing petitioner's complaint against five appellate judges and four district judges of the First Circuit (Complaint Nos. 01-22-90021 - 01-22-90029). Chief Judge Barron dismissed Complaint No. 01-22-90001 as frivolous and not cognizable, pursuant to 28 U.S.C. §§ 352(b)(1)(A)(iii) and 352(b)(1)(A)(ii), and Rules for Judicial-Conduct and Judicial-Disability Proceedings (Rules of Judicial-Conduct), Rules 11(c)(1)(C) and 11(c)(1)(B). Judge Montecalvo dismissed Complaint Nos. 01-22-90021 - 01-22-90029 as baseless and not cognizable, pursuant to 28 U.S.C. §§ 352(b)(1)(A)(iii) and

352(b)(1)(A)(ii), and Rules of Judicial-Conduct, Rules 11(c)(1)(D) and 11(c)(1)(B). A review panel of the Judicial Council of the First Circuit has considered the petition for review and the relevant materials, and has concluded that the petition for review should be denied for the reasons stated in Chief Judge Barron's and Judge Montecalvo's orders of dismissal, respectively. See Rules of Judicial-Conduct, Rules 18(a) and 19(b)(1), and First Circuit Local Rule 19(a).

Accordingly, the orders of dismissal issued in Judicial Misconduct Complaint No. 01-22-90001, and in Judicial Misconduct Complaint Nos. 01-22-90021, 01-22-90022, 01-22-90023, 01-22-90024, 01-22-90025, 01-22-90026, 01-22-90027, 01-22-90028, and 01-22-90029, respectively, are affirmed.
